Angela Villani presents the financial operations report as of April 2020. MBACS budgeted total enrollment at 1328 but the BoE approved an increase of 173 students. MBACS budgeted 283 special education students. The School District is paying MBACS regular education enrollment of 1043 and special education enrollment of 285. General Fund Revenue over expense current –\$2,795,613 under projected budget by \$115,721. Cash is \$5,702,388 - 107 days of cash on hand at 4/30/2020. 45 days required by bond covenant.
