## IV. Oral Reports

#### a. Academic Committee

Rosalie Guzofsky states that at the January Academic Committee Meeting, the committee discussed the college and career readiness curriculum, school activities that took place in quarter two, and reviewed release PSSA questions.

#### **b.** Finance Committee

Brian Foley states that the finance committee reviewed the December Financials, which show a projected surplus of just over \$2 million. The increase is driven by higher reimbursement rates. The school is exploring new costs related to the school's new parking lot, a possible addition, and enhancements to the auditorium. Cash on hand is 132 days.

#### c. Governance Committee

Leah Murphy states that the Governance Committee has a training scheduled for February 24, 2025. This will be a two hour training that is required for new members, but open to all members. An additional 2 hour training will be scheduled for later this year. All members are also required to complete 1 hour of trauma training. The onboarding process for new members continues to be the top priority of the committee.

#### d. Enrollment

Angela Villani states that current enrollment is 1502. Average daily attendance year to date is 92%.

# e. Discipline

Andrew Boglioli states that there were 26 out of school suspensions and 35 in school suspensions in January.
